You must complete a clinic, practica, or externship at a government agency or agency that serves, represents, or advocates on behalf of indigent persons, disadvantaged groups, or inadequately protected interests:

### Co-Curricular Experience

You must complete 30 hours of public service work. This work does not need to be at one organization and it need not be completed prior to enrolling in the Public Interest Law Seminar.

## Applying for your Certificate

After completion of all requirements, you must complete an application ([https://luclawschool.formstack.com/forms/public\\_interest\\_and\\_social\\_justice\\_certificate/](https://luclawschool.formstack.com/forms/public_interest_and_social_justice_certificate/)) for the Certificate in Public Interest and Social Justice. Submit a completed application to the Director of Public Interest Programming for signature. You must then submit your signed application form to the Law School Registrar's Office.
